On the basis of marks of Written Objective Screening test held on **12th August, 2012** and personal interview conducted w.e.f. **19-09-2012 to 15-10-2012** and In compliance to the orders of the Hon'ble High Court dated **12-12-2012**, the personal interviews of **95** candidates were conducted on **04/01/2013, 29/01/2013, 08/03/2013 and 26/4/2013**. Further in compliance to the orders of Hon'ble High Court in **CWP No. 11753/2013** in **CWP No. 8858/12** dated **2nd July, 2013**, Board had compiled the result after redrawing merit of **103 posts** of **PGT (Commerce) (On Contract) Post Code-305** against Advertisement No. **22/2011** Dated **13th December, 2011**.

Now in compliance to orders passed by the Hon'ble High Court in **CWP No. 8858 of 2012** titled **Ramesh Kumar & Others V/S State of HP & Others** on dated **12-12-2012** and **Review Petition. No. 4065/13** on dated **24th April, 2014**, **36** candidates bearing following Roll Nos. in their respective categories have also been declared successful on the basis of re- drawn merit in addition to already recommended 103 candidates vide Press note issued on dated **21-11-2012**. These appointments shall be made, provided the post are available and also subject to the condition that these 36 candidates pass **B.Ed. with in three years**. The marks secured by the successful candidates have also been shown against their roll numbers.
