**Addendum to Advt. No. 30/2015 dated 13.2.15**

This is with reference to advertisement issued vide advt. no. **30/2015 dated 13.2.15 published** in The Hindustan Times and Amar Ujala on dated 19.2.1015, vide which **30 posts** of JE Civil Post code 415 (on contract basis) in the pay band of Rs. Rs, 10300-34800+ Rs. 3800/-GP of Public Works Department were advertised.

A corrigendum was issued on dated 21.2.15 to withdraw the 30 posts of J.E. Civil ( Post code-415) due to administrative reasons since there were some technical problems in R & P Rules as intimated by the Requisitioning Authority.

Now the department concerned has sent an amended copy of R & P Rules for filling up of 30 posts of JE Civil on contract basis in the pay scale of Rs. 10300-34800+3800 GP.


**The essential qualifications as per amended R & P Rules for the post of JE Civil are as under:-**

- i) Should have passed matriculation examination or its equivalent from a recognized Board/University.
- ii) Regular full time Diploma in Civil Engineering (3Years) or its equivalent from an Institution/University duly recognized by the Central or State Government."

The applications on the prescribed Proforma, in sealed covers, are invited for the 30 posts of Junior Engineer(Civil) Post code 415 in Public Works department so as to reach the **Secretary, Himachal Pradesh Subordinate Services Selection Board, Hamirpur (Himachal Pradesh) PIN-177001** on or before **30.4.2015**. However, for the candidates residing in Lahaul & Spiti District, Kinnaur District, Pangri & Bharmour Sub-Divisions of Chamba District and Dodra Kwar Sub-Division of Shimla District of Himachal Pradesh, the last date for receipt of applications is **15.5.2015**. The applications received after these dates shall not be entertained. The Board will not be responsible for delay in receipt of applications due to any reasons what so ever.

**NOTE:- Now therefore, the candidates who had applied earlier for the post of Junior Engineer (Civil) under post code 415 in compliance to the Advt. no. 30/2015 dated 13.2.15 and fulfill the essential qualifications as per amended R & P Rules need not apply again/ afresh.**
