Limited Advertisement

This limited advertisement is issued to invite the applications from **the petitioners and similarly situate persons** who acquired / possessed the qualification of M.Sc. (IT) on or before **12.1.2012**, in compliance with the directions of Hon'ble High Court in CWP No. 2977/2013 titled as Manoj Kumar and others Versus State of Himachal Pradesh and others, and further in continuation of advt. no. 22/2012 dated 13.12.2011 in which **767 posts of PGT (Informatics Practices) (Post Code 311)** for different categories / sub categories on contract basis in the pay scale of Rs. 10300-34800+4200 GP (Consolidated fixed contractual amount @ 14500/- Per Month) were advertised.

- The last date for receipt of application form for normal area is 10/10/2013 and the candidates residing in Lahaul & Spiti District, Kinnaur District, Pangi & Bharmour Sub-Divisions of Chamba District and Dodra Kwar Sub-Division of Shimla District of Himachal Pradesh, the last date for receipt of applications is 17/10/2013. The applications received after these dates will not be entertained. The Board will not be responsible for delay in receipt of applications due to any reasons what so ever.
 - The candidates who acquired the qualification of M.Sc (IT) after 12-01-2012 are not eligible to apply under this Limited Advertisement for above posts.
 - The candidates who participated earlier in the selection process (including those having qualifications of M.Sc. (IT), who were allowed by the Hon'ble High Court) need not to apply again as the said selection process shall remain undisturbed as per the direction of the Hon'ble Court.
 - The candidates having qualification other than M.Sc (IT) are not eligible to apply under this Limited Advertisement for above posts.
1. **Age:** The applicant should be between 18 to 45 years as on **13-12-2011**. Upper age limit is relaxable by five years for candidates belonging to Scheduled Caste, Scheduled Tribe and Other Backward Classes, Persons with disabilities & Children/Grand Children of Freedom Fighters of Himachal Pradesh. The upper age relaxation is also available to Ex-servicemen candidates of H.P. as per provision of relevant rules/instructions of H.P. Govt.
 2. **Application Forms:** - Application forms are available in all the post office/sub post offices of Himachal Pradesh. The cost of application form is Rs. 320/- for General Category Candidates and Rs 110/_ for reserved categories.

Note: - Ex-Servicemen and visually handicapped candidates are exempted from examination fee.
However Ex-Servicemen released on their own request are not entitled for fee exemption.

4. Documents to be sent with the application Form

- i) One window envelope (made available in the packet of application form) after affixing postal stamps of Rs. 6/- or of prevalent rate
- ii) One passport size recent photograph (Not to be attested) of the candidate pasted on Prescribed box in the Application form.

- iii) Acknowledgement Card (made available in the packet of application form) after affixing postal stamps of Rs. 6/- or of prevalent rate after writing self-address thereon

5. General Instructions:

- i) The candidate must apply on the prescribed Application form costing Rs. 320/- (For General Category) and Rs. 110/- (for reserved categories) obtainable from the Post Offices/ Sub-Post Offices.
- ii) The Application form should be filled in by the candidate in his/her own handwriting with blue/black ink ball point pen.
- iii) The candidate shall write his/her name as per the matriculation certificate in the relevant column of the application form.
- iv) Incomplete application forms e. g. declaration not signed, without photo and enclosures i. e. Acknowledgement Card, window envelope etc. not attached and columns not filled in or applications received after the due date shall be rejected summarily without assigning any reason.
- v) In-service candidates shall be required to produce the N.O.C. from the concerned department at the time of personal interview. They should send their original applications direct to the Board under intimation to their controlling officer.
- vi) The Candidates selected for appointment to various posts on Contract basis will have to execute a contract with the concerned appointing authority as per the provisions of the Recruitment & Promotion Rules of the post.
- vii) The amount of fee has been included in the cost of Application Form. Hence the candidates need not attach any fee with the Application.
- viii) Candidates claiming fee concession and applying on subsidized forms costing Rs. 110/- should possess a valid certificate of the respective category as on the last date of submission of application & the copy of the certificate is required at the time of interview, failing which the candidature is liable to be cancelled at the interview stage.
- ix) No change of category shall be allowed after last date of receipt of application forms i.e. from SC to OBC/ST & vice-versa.
- x) Married daughters/ grand-daughters of freedom fighters are not entitled for reservation under Ward of Freedom Fighter Sub category. Preference will be given to the children of Freedom Fighters over Grand Children.
- xi) **The certificate of Scheduled Caste, Scheduled Tribe, Other Backward Classes should be on parental basis.**
- xii) Since the validity of OBC certificate is of two years from the date of its issuance, the candidates are required to furnish the valid certificate in support of his/her claim. The validity of the certificate is required to be seen at the time of interview.
- xiii) Eligibility for vacancies in Sub-Category of SPORTSMAN shall be as per the norms framed by department of Youth Services and Sports.
- xiv) **Only Himachali candidates belonging to SC/ST/OBC will be eligible for the posts reserved for respective categories.**
- xv) **No change of category at any stage shall be allowed.**
- xvi) **The validity of IRDP/BPL certificate is of six months from the date of its issuance. The candidates are required to furnish the valid certificate in support of his/her claim. The validity of the certificate is required to be seen at the time of interview.**
- xvii) **The candidates must fill in the relevant sub columns of **Column No. 17** of application form for educational, professional, technical and other required qualifications as per advertisement of the concerned post code.**
